- Managed all data operations for the countywide CalKIDS initiative – negotiating data sharing agreements with the State Treasurer’s Office, designing the integration pipeline, and delivering Tableau dashboards monitoring individual and aggregate outcomes – supporting 23 districts in registering over 32,000 students and facilitating access to \$16,000,000 in college savings funding.
- Built and managed the data systems for the CSU Direct Admissions Pilot, combining CCGI and CALPADS data via Python API integration with Google Sheets to deliver individualized on-track status reports to counselors at every high school in Riverside County, serving 19,000+ students with school-level permissioning and supporting nearly \$3,000,000 in direct student financial impact across two years. Negotiated the data sharing agreement to enable the partnership.
- Provided direct data support for the SBHIP Needs Assessment and facilitated coordination between Managed Care Plans and school districts, contributing to a successful submission to DHCS that resulted in over \$7,000,000 in mental health grants awarded to participating districts.
- Architected an on-premises countywide data system (RHEL 9, Kubernetes, Docker, Airflow, dbt, SQL Server, Minio, Tableau with row-level security), establishing RCOE’s first integrated data warehouse supporting standardized reporting across the Educational Services Division.
- Navigated data privacy and data sharing requirements across multiple initiatives, leading DSA negotiations with external partners (State Treasurer’s Office, CSU system) and advising internal teams on FERPA compliance, statutory requirements, and cross-agency data governance.
- Provided direct data and evaluation support across the Superintendent’s Initiatives, including coordination between Managed Care Plans and districts (SBHIP), suicide prevention (SPARE), socioemotional learning (CalHOPE), and Whole Health Screening (MHSSA).
- Co-led the Statewide Data Visualization COE Network with the San Diego County Office of Education, building data visualization capacity across county offices statewide.
- Established a cross-divisional Student Data PLC at RCOE spanning Educational Services, Student Programs and Services, Early Education Services, Leadership, Wellness, and Student Services, addressing technical and programmatic data system needs across the organization.
- Provided technical leadership across the AACI data team (two administrators, a coordinator, temporary contractors, and interns), supporting a 48% increase in data project volume (101 projects in 2025–26 vs. 68 prior year) while cross-training new staff in evaluation, survey design, and research request fulfillment.

- Developed a custom LCAP analysis web application (Vue.js/FastAPI) to categorize district LCAP actions and services, identifying thematic trends across 23 districts and enabling cross-district comparison of improvement strategies for unduplicated pupils.
